



COVID MANDATED PROTOCOLS

In General

To maintain the **allowed numbers of people in the building** at all times and maintain other COVID requirements throughout the building, the following **procedures must be followed** by all Team members, Guests and Staff. There are **no exceptions** to these requirements unless noted. If necessary, other requirements may be instituted.

1. **All Attendees** (Team members, Guests, Staff) must have a **daily screening for COVID symptoms** immediately upon entering the building each day and obtain a Daily Screen Sticker or wristband
 - a. Stickers and wristbands must be worn and clearly visible at all times
2. **All Attendees must wear a mask completely covering their nose and mouth at all times, except while actually eating in designated areas**
 - a. **Gaiters, mesh masks, bandanas or face shields are not acceptable**
 - b. **Penalties may be assessed on a team whose members or Guests do not cooperate**
 - c. **Attendees not cooperating may be denied further entry**
3. **All Attendees must maintain prescribed social distancing**
 - a. Please follow directions for traffic, seating
4. Food of any kind or drinks other than plain water may be consumed in designated areas only
 - a. Tables and chairs available in lobby and food areas at street level
 - i. Chairs may not be moved to another location
 - b. Outside food may not be brought into the building

Courtside

To maintain the **allowed numbers of people in the playing area** at all times, and maintain other COVID requirements, the following procedures must be followed by all Team members, Guests and Staff. There are **no exceptions** to these requirements unless noted. If necessary, other requirements may be instituted.

1. **All Attendees** (Team members, Guests, Staff) entering the playing area **must have their Entry Pass scanned and Daily Screen Sticker or wristband checked** at each entry
2. **All Guests, coaches and players whose team is not actively playing or officiating must leave the playing area as soon as their match is completed.**
 - a. **Readmission for next match only after match ahead is completed (not during the last few points) and those Guests and teams have cleared the court area**
 - i. **Team(s) and all Guests from finished match must exit before Team(s) and Guests for next match are admitted**
 - ii. **Players and Coaches readmitted first, then Guests**

3. **All Attendees must wear a mask completely covering their nose and mouth at all times, including while playing**
 - a. **Play on the court will be suspended if this mandate is not followed**
 - i. **Penalties may be assessed for team whose members or Guests do not cooperate**
 - ii. **Attendees not cooperating may be denied further entry**
4. All Attendees must maintain prescribed social distancing
 - a. All **Team Coaches and Guests** must be **seated** in appropriately marked seats while in the court area
 - i. **Coaches** whose teams are playing may **follow USAV Rules** for sideline actions
 - ii. Team **substitutes** and team members **officiating** are **excepted**
 - iii. Trips to the Rest Rooms are exceptions
 - iv. Attendees may not use seats marked for “Not In Use”
 - v. Attendees may not move chairs
 - b. Players, coaches and Guests must **stay at the court** they are **assigned** to
5. **No food** of any kind **or drinks** other than plain water may be in the playing area
 - a. Includes eating at the Score Keepers table
